

Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 7/2/2021 I responded to 3608 Coventry Way for a report of a male needing to be removed from the residence. Upon arrival, I located a male identified as Edward Mathews, on the corner of Coventry Way and Gramercy Way making a phone call but using loud and offensive language. He was immediately confrontational and it was apparent he was the male in question. After some time, he left the area and returned to his residence. Shortly after, it was learned that the resident/caller at 3608 Gramercy responded to MLPD and reported bias harassment charges. Shortly after, I received a call from 1102 Coventry Way for a threats complaint. Upon arrival, I could observe the same male, identified as Edward Mathews, in a verbal altercation with four parties at the front steps of 1101 Coventry Way. He can be heard addressing parties using racial slurs such as "monkey" and "nigger" as well as intimidating victims saying he ran other residents (African American and HOA Board Members) out of the community and that MLPD can't do anything about it. I contacted Mathews who, confronted me in an agitated manner and told me to go "talk to the niggers" and "tell them about me". I was able to convince Mathews to leave the area and allow me to conduct an investigation without him peering from the nearby sidewalk. Upon leaving he yelled to approximately ten bystanders that "did you know monkeys live here?" and yelled to the victims "fucking niggers." I spoke to the victims and they reported the following. On this date, Denise Brown, (Caucasian Female/Non Board Member) answered her door and was confronted by Mathews demanding to see her husband, Leron Brown, (African American/HOA Board President) over HOA business. During this time, Mathews attempts to enter their house by opening the storm door which he closes and never answers. He then immediately wipes off the handle with his t-shirt in an attempt to destroy fingerprint evidence. Denise Brown then retreats further into the house and notifies MLPD via 911 and a neighbor. Her neighbor, Etchu Tambe, responded to the residence and is confronted by Mathews in the common walkway leading to the residence. Tambe then steps aside allowing Matthews to leave and takes refuge on the steps of 1101 Coventry Way. Mathews can be seen on three occasions closing distance with Tambe and once appears to try and kiss or lick him in an attempt to escalate the altercation. continued ...

2. I am aware of the facts above because: (Included, but not limited to: your observations, statements of eyewitnesses, defendant's admission, etc.)

Mathews refers to Tambe as a "monkey" and a "nigger" and admits to harassing Tambe at this point and chest bumps him several times. Moments later, Tambe's wife, Marilyn Tambe, arrives on location and begins to record via cell phone from a distance. Mathews could be heard stating that MLPD can't do anything in additional attempts to intimidate the victims. He then admits to running off Verlin and her daughter who are members of the HOA Board and details the manners in which they were harassed and targeted. He then turns his attention to Marilyn where he also addresses her as a "monkey" just prior to my arrival. He then invites all victims to his residence and to bring whoever in what appears to be an attempt to escalate this confrontation to a physical encounter. While inside the residence, Mathews slowly drove by the residence and peered at onlookers saying they don' want to be a part of this. I spoke with several onlookers who felt like he was attempting to threaten them. continued...

3. If victim was injured, provide the extent of the injury:

The initial caller, Denise Brown, was visibly shaken and crying during her statement to me. She pleaded to post additional security around her residence in fear for her safety and security. The remaining victims all informed me of the ongoing issues and how they feel like nothing can or is being done to stop the problem. They all felt some level of harassment and threats due to Mathews level of agitation and demeanor and racial slurs/threats directed at them regarding their race and status as victims. No physical injuries were sustained there was an increased level of fear in the victims at the completion of this call for service. All or some of the interaction was caught on one of three devices. One "ring" camera mounted to the outside of the house and cell phone videos provided by Marilyn Tambe and Leron Brown.
