Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 07/02/2021 Patrols responded to MLPD HQ for a walk in to report a harassment by a neighbor. I spoke with the victim, Verlyn H. Gibbons (African-American female), who stated her neighbor, Edward C Mathews, was harassing her by approaching her front door, shouting offensive language and racial slurs at her. Ms. Gibbons stated she spoke with a detective earlier in the day and was expecting them to respond to her home after reporting a prior criminal mischief to her vehicle, which she suspected Mr. Mathews of committing. Ms. Gibbons answered the door expecting the detective but instead was met by Mr. Mathews cursing at her and denying being a suspect to the criminal mischief to her vehicle. Ms. Gibbons stated she quickly closed the door to protect herself from Mr. Mathews. Video surveillance of this incident is captured on Ms. Gibbons Ring doorbell camera. Ms. Gibbons called police who responded and spoke to Mr. Mathews about the incident. Patrols are seen leaving the area and then Mr. Mathews is captured on Ms. Gibbons Ring doorbell walking his dogs to the front yard of Ms. Gibbons home. Mr. Mathews is seen on Ms. Gibbons security camera, looking directly at the camera and thrusting his hips in a lewd motion while laughing. Mr. Mathews then begins to walk away and while still looking at the camera, he can be heard saying fucking monkey. The racial slur is in reference to Ms. Gibbons African-American race and is an attempt to intimidate the victim, since she is on the housing association board and Mr. Mathews wants her to move out of the neighborhood. Ms. Gibbons stated she has been called a nigger bitch and fucking monkey by Mr. Mathews various times over the last few months but those incidents have not been captured on video. Ms. Gibbons also provided a signed written statement of the incident.
