Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:  
On 7/2/2021 Officer White responded to 1101 Coventry Way for a report of a male needing to be removed from the area. Upon arrival, Officer White observed the same male, identified as Edward Mathews, in a verbal altercation with four parties at the front steps of 1101 Coventry Way. He can be heard addressing parties using racial slurs such as "monkey" and "nigger" as well as intimidating victims saying he ran other residents (African American and HOA Board Members) out of the community and that MLPD can't do anything about it. Officer White contacted Mathews who, confronted him in an agitated manner and told him to go "talk to the niggers" and "tell them about me". Officer White was able to convince Mathews to leave the area and allow him to conduct an investigation without him peering from the nearby sidewalk. Upon leaving he yelled to approximately ten bystanders that "did you know monkeys live here?" and yelled to the victims "fucking niggers." Officer White spoke to the victims and they reported the following. On this date, Denise Brown, (Caucasian Female/Non Board Member) answered her door and was confronted by Mathews demanding to see her husband, Leron Brown, (African American/HOA Board President) over HOA business. During this time, Mathews attempts to enter their house by opening the storm door which he closes and never answers. He then immediately wipes off the handle with his t-shirt in an attempt to destroy fingerprint evidence. Denise Brown then retreats further into the house and notifies MLPD via 911 and a neighbor. Her neighbor, Etchu Tambe, responded to the residence and is confronted by Mathews in the common walkway leading to the residence. Mr. Tambe then steps aside allowing Mathews to leave and takes refuge on the steps of 1101 Coventry Way. Mathews can be seen on three occasions closing distance with Mr. Tambe, chest bumping him and appears to try and kiss, lick or spit at him in an attempt to escalate the altercation.
